WASHINGTON – Attorney General Eric Holder will travel to Algiers and Madrid next week to discuss cooperation on combating terrorism and enhancing law enforcement coordination. The Attorney General will meet with the Algerian Minister of Justice to sign a mutual legal assistance treaty and will participate in the biannual European Union Justice and Home Affairs Ministerial Conference in Madrid.
