INTRODUCTION

What we include in the Interim Relief Docket

The 2024-25 term ran from October 7, 2024, through October 5, 2025. (We refer to it as the 2024 term throughout this Stat Pack.)

The Interim Relief Docket consists of cases during that term in which the Supreme Court granted or denied an application for emergency relief that was initially presented to an individual justice and then referred to the full court for final decision.

We excluded applications that converted to the merits docket without a ruling on emergency relief, such as *TikTok, Inc. v. Garland*, where the court deferred the application pending oral argument. We also excluded routine procedural matters, such as requests for extensions to file briefs. (Please note that these cases are included in the Term Index for transparency.)

How the Interim Relief Docket Differs from the Merits Docket

Justices are not required to disclose their votes on emergency applications publicly. Therefore, unlike in merits cases, we do not know the vote breakdown (6-3, 7-2, etc.) unless four justices publicly disclose their disagreement.

Dissents fall into two categories: disagreement statements and formal dissents. Disagreement statements reveal a justice's voting preference ("Justice Gorsuch would have denied the application"), dissents indicate a justice's formal opposition ("Justice Kagan dissents"). To maintain consistency with the Supreme Court's tracking, we combine these two categories.

Justices can also file a formal concurrence or issue a statement respecting either the denial or grant of the requested relief.

Thanks to Jake Truscott and Adam Feldman for their guidance and generosity in sharing the framework that makes the merits docket stat pack such a valuable resource. This project is modeled on their work.

INTRODUCTION

Interim Relief Application Categories

There are three kinds of applications on the interim relief docket:

Capital cases are requests to stay or vacate stays of execution. They have traditionally dominated the docket, although their share has declined from over 78% in 2005 to 36% in 2024. During the 2024-25 term, there were 49 such requests, and none were granted. Only 3 of those cases had any public disagreement.

Refiled applications occur when an applicant, after being denied by one justice in chambers, refiles with another; these are almost always denied, and only one refiled application has been granted since 2000.

Substantive applications now represent much of the core work of emergency relief – these are typically requests for stays, injunctions, or other intervention in non-capital matters. These have grown from just 5% of the interim relief docket in 2005 to 40% in 2024.

INTRODUCTION

Key Findings in the Stat Pack for the 2024-25 Term

Rising Volume, Rising Grants. The court received 136 emergency applications this term – 55 substantive applications after excluding 49 capital cases and 32 refilings. Of the 55 substantive applications, six were deferred for oral argument, leaving 49 substantive cases for statistical analysis. The court granted relief in 49% of substantive applications, nearly double the 23% grant rate from the previous term.

Public Disagreement at Historic Highs. Justices publicly disagreed in 74% of substantive applications – far exceeding the pre-2014 average of 13.5% and more than double the 2022 and 2023 terms (at 25%). The liberal bloc (Sotomayor, Kagan, Jackson) frequently disagreed together, while conservative justices more often disagreed individually.


Jackson Leads in Public Statements. Justice Jackson led all justices with 22 total public statements (15 dissents, 7 disagreements), followed by Justice Sotomayor with 18. Among conservatives, Justice Thomas led with 15 statements – although 13 of these were disagreements rather than formal dissents. Justice Kavanaugh led in concurrences with 4.

The "Shadow" Continues to Lift. Written opinions accompanied 31% of substantive applications, continuing the dramatic increase from near-zero during 2015-17 and 23% in 2023.

Speed Varies Dramatically. Average time from filing to decision for substantive cases was 36 days, with a median of 22 days. The fastest decision came in just 1 day ([Trump v. New York](#)), while 33% of applications were resolved within 1-2 weeks.

Trump Administration Dominates the Docket. The Trump administration filed 27 of the 55 substantive applications (49%), far outpacing private parties (19) and states (9). The court granted relief in 19 of 21 cases with clear outcomes (90%), compared to just 2 denials. Only 2 of the 23 Trump cases were decided unanimously (9%), with justices publicly disagreeing in 91%. These cases were resolved nearly twice as fast as others, averaging 21 days compared to 36 days for all other substantive applications. (No Biden administration analysis was conducted because there were no such cases brought by the Biden administration between the October 2024 term start and January 20, 2025.)


TOTAL OPINIONS OVER TIME



This figure shows the volume and proportion of emergency applications by category (substantive, capital, and refiled) between the 2005 and 2024 terms.


2024 Interim Relief Docket: By the Numbers


UNANIMOUS DECISIONS


Who is Bringing Applications?

This figure shows the distribution of 49 substantive applications by issue area, classified using [Supreme Court Database](#) methodology.



Days between applications and orders




This Figure shows the average number of days from filing to decision for substantive emergency applications by term. The **dashed red** line represents the longitudinal average.


Average Opinion Length by Type

2024 Term - Substantive Applications








Trump Administration Emergency Applications: Unanimity

This figure shows the distribution of Trump administration applications by issue area, classified using [Supreme Court Database](#) Methodology.




